

Federal Judge Issues Preliminary Ruling in Favor of UF Faculty and Academic Freedom

In late October, the University of Florida infringed upon the academic freedom and First Amendment rights of three political science professors and UFF members—Drs. Sharon Austin, Dan Smith, and Michael McDonald—by denying their requests to participate as expert witnesses in a voting rights lawsuit against the state of Florida. Your union sprang into action immediately by coordinating protests, contacting local and national press, and securing state and national affiliate support in the struggle. After the university allowed them to participate in the suit, these faculty went on to pursue a federal suit against the university, in hopes of stopping them from infringing upon the academic freedom of other faculty in the future.


In mid-January, Judge Walker issued a scathing rebuke of University of Florida administration, comparing their actions to those of a university in Hong Kong engaging in anticipatory obedience, lest they anger the ruling Chinese government. He also placed a temporary injunction upon the university's conflict of interest policy until the suit has reached a conclusion in court. UFF Hosts Gubernatorial Townhall

In mid-December, UFF hosted a townhall event for Florida's gubernatorial candidates. While all candidates were invited, U.S. Representative Charlie Crist, Commissioner of Agriculture Nikki Fried, and Florida state Senator Annette Taddeo chose to participate. Questions for the event were sourced from UFF members across the state. UFF President Andrew Gothard served as moderator, with multiple UFF and FEA leaders bringing questions that urged candidates to clarify their support for higher education issues, including academic freedom, free speech, and state funding.

The townhall was a resounding success, with the recorded event receiving thousands of views online and wide press coverage from multiple outlets. The candidates' answers and perspectives will be a critical part of UFF's eventual endorsement in the governor's race later this year. Legislative Updates

Though it's only the second week of February, over four weeks of the legislative session have already gone by, and they've been anything but calm. Of most importance to higher education, **SB 520—the 'Secrecy in University and College Presidential Searches' bill**—has already passed through three committees and is on its way to a vote on the Senate floor

Stop SB 520!

All UFF members should take action to stop SB 520 by following the instructions in the <u>UFF</u>

SB 666 and SB 810 have both been assigned to the Senate Education Committee, while HB 6077 and HB 769 have both been assigned to the Postsecondary Education & Lifelong Learning Subcommittee. This is a great start, but it is only the beginning.

"Viewpoint Discrimination" Lawsuit Update

UFF's lawsuit against the State of Florida regarding HB 233, the "Viewpoint Discrimination" law, is continuing through the "discovery" phase, though we have yet to receive a ruling on the state's motion to dismiss.

Recently, Judge Walker asked legal representation on both sides to file briefs addressing the recent Supreme Court decision in *Whole Woman's Health v. Jackson* and its implication for the state's pending motion to dismiss. We believe that our argument show the strength of our case and the weakness of the state's defense, and we look forward to receiving the judge's ruling.
