United Faculty of Florida (UFF) Demands Names of the University of Florida President Finalist Candidates

The United Faculty of Florida (UFF) questions the legality of nominating U.S. Sen. Ben Sasse as the sole candidate for University of Florida (UF) president. In mid-October, Florida state Sen. Jeff Brandes — who co-sponsored the bill that took Florida's university and college presidential searches out of the sunshine — stated that UF's recent search resulting only in Sen. Sasse violated the spirit of the law (source link). At UFF, we believe that it violates the letter of the law as well.

Florida Statute 1004.098, which governs public records exemptions for university and college presidential applicants, makes no mention of allowing a single applicant to nullify the requirement for "the final group of applicants" to be no longer exempt from Florida's Sunshine Laws. Instead, under this statute the University of Florida is required to provide the following in their search process:

- 1. "the age, race, and gender of all applicants who met the minimum qualifications established for the position"
- 2. "the personal identifying information of an applicant included in the final group of applicants"

The University of Florida has stated on its own website that the full list of applicants included "more than 700 leaders within and outside of higher education," and the final pool of applicants was composed of "a dozen highly qualified and diverse candidates. Nine were sitting presidents at major research universities, and seven were from AAU universities."

As a result, earlier today the United Faculty of Florida submitted a public records request to the University of Florida demanding the information required by Florida statute of the full list of more than 700 applicants and the personal identifying information of the final pool of 12 candidates for the position, in addition to records of meetings that discussed the final group of applicants.

If the university resists its obligations under Florida statute, UFF and our allies intend to take legal action to compel the release of this information and to delay the hiring of any UF president until this statutory requirement has been met. The university community deserves to know which candidates in this search process were considered less qualified than Sen. Sasse, in order to decide for themselves who will make the best president of UF.
